- (4) THE COMPLETED APPLICATION AND SUPPORTING DOCUMENTATION MUST BE SUBMITTED AT A PRESBYTERY MEETING BY A RULING ELDER. THE INFORMATION SHOULD BE PROVIDED TO A MEMBER CONDUCTING THE MEETING REGISTRATION.

TERMS AND RESTRICTIONS

FOLLOWING ARE THE TERMS OF THIS GRANT:

- (1) GRANT LIMIT OF 50% OF PROJECT TO A MAXIMUM OF \$2,000.
- (2) ONLY ONE GRANT OR LOAN PER CHURCH WILL BE AWARDED EVERY 3 YEARS
- (3) THE COORDINATING TEAM WILL ULTIMATELY DECIDE WHETHER EACH GRANT SHOULD BE APPROVED, SUBJECT TO RECOMMENDATION FROM THE FINANCIAL PLANNING COMMITTEE
- (4) THE TOTAL OUTSTANDING GRANTS TO ALL CHURCHES WILL BE CAPPED AT \$30,000 PER YEAR.
