# Park Presbyterian Church



# History

Park Presbyterian Church in Beaver is delighted to be hosting the March, 2023 meeting of the Beaver-Butler Presbytery. Park was originally founded as an Associate Presbyterian congregation on August 1, 1853 under the care of the Ohio Presbytery. In 1858 when this denomination merged with the Associate Reformed Presbyterian Church the congregation took on the name Beaver United Presbyterian Church, to follow the denomination's lead. In 1959, following another denominational merger the congregation voted to change the name to Park United Presbyterian Church. The United was dropped following the 1983 merger of the northern and southern expressions of Presbyterianism, with the formation of the Presbyterian Church (U.S.A.).

The congregation's first building was at the corner of Third Street and Wilson Avenue. In 1904 the present property was purchased and the current sanctuary erected. As the community and the congregation continued to experience growth the need for an educational wing arose. This construction was put off for a period as mission causes and the financial support was deemed of greater importance. Construction finally began in 1929 and was completed in 1931.

Proud of their new facilities, the congregation hosted the 74th General Assembly of the United Presbyterian

Church in May of 1932. There is a long list of renovations and details of the pastors who served Park Church over the years in the 2003 history booklet, developed in celebration of the 150th anniversary. At that time the educational wing was given a total renovation, providing for the Gathering Room space, full handicap accessibility, new offices and classroom designs. More recent updating has included repair of the stained glass windows and the 2020 painting of the sanctuary.

# **Ministry**

Mission engagement, music, education, youth and summer camp ministries have been hallmarks of this congregation. Park Church is currently being served by the Rev. Todd Allen.

### Location

Park church is located at the corner of 3rd Street (Route 68) and Commerce Street just to the west of downtown Beaver. The church is directly across from the Beaver County parking garage. All parking, in the garage and along area streets is free. Corporation Street runs immediately behind the church; Corporation and Commerce are one-way streets. Park Church is fully handicapped accessible.

After an opening anthem, "Glory to His Blessed Name," and a reading from Hebrews 11:39 – 12:3, Vice-Moderator the Rev. Jamie Fowler spoke about her experience of being in a race. It is good for us, as the Church together, to remember God's faithfulness to us. Those who make up our own *Cloud of Witnesses* did everything they did *by faith*. Their lives and ministry have been a positive influence on our own lives. Their influence has edified our own faith. We are truly surrounded by a great *Cloud of Witnesses*. For ourselves, we are still in the race, and we need to be encouraged to continue the race. This passage encourages us to keep running, and "slogging."

Moderator Paulsen and Vice-Moderator Fowler read the names of Teaching Elders, Ruling Elders, Deacons, and Trustees who had entered the *Church Triumphant* in 2022. Vice-Moderator Fowler closed the time of recognition with prayer.

# HONORING THE MINISTRY OF CALVARY PRESBYTERIAN CHURCH, BEAVER FALLS: Elder David Hartzell

Elder Hartzell spoke about the history and nearly 200-year ministry of Calvary Church. He thanked the members of the Administrative Commission who guided the Church through the process, and offered a brief description of the founding and history of the congregation. Calvary was the "mother church" of three congregations: Steffin Hill, College Hill, and a church in Chippewa.

As he closed, he encouraged the Commissioners to continue to hold the Calvary members in prayer, as they discern where God is leading them next.

# BEAVER-BUTLER PRESBYTERY STRENGTHENING CONGREGATIONAL CONNECTIONS GRANT

### **PURPOSE**

Trusting in Jesus' proclamation that "where two or three are gathered in my name, I am there among them" (Matthew 18:20), the Strengthening Congregational Connections Grant is available to assist congregations partnering together to use their energy, intelligence, imagination, and love in a **new** shared project of ministry and mission. A grant of up to \$500 per each participating PC(USA) congregation of the Presbytery may be available upon application. Applications for projects involving more than three congregations will be considered on a case-by-case basis.

# **PROCESS**

- With at least one other congregation in the Presbytery, come up with a creative and compelling idea for a new ministry, mission, or fellowship event.
- Complete the attached application form and submit it to the Presbytery Office.
- Upon receipt, the Collaboration, Fellowship and Youth (CFY) ministry unit will consider the application at its next stated meeting and will respond shortly thereafter.

# REQUIREMENTS

- The proposed initiative must facilitate <u>at least two congregations of the Presbytery</u> working to build the reign of God among Beaver-Butler Presbytery. Initiatives may be ecumenical and/or interfaith, but there must be at least two congregations of the Presbytery involved in leadership and implementation. Only one participating church needs to submit the application, and a representative from this church will be responsible for handling financial matters.
- The Sessions of all churches involved must approve the event and proposed funding.
- Each individual church may only receive one grant per calendar year. Applications will be accepted through November 30, 2023. CFY will evaluate the grant process at the end of 2023 for future consideration.
- Upon approval, the initiative may be shared so others can also participate.
- The event must happen within twelve months of receiving the funds.
- Following the event, photos/videos and feedback should be shared with CFY.

# **INFORMATION TO CONSIDER**

- If you have an idea for an event but aren't sure who might make a good partner, share your idea with local churches to see if another congregation may be interested. The Presbytery Office and CFY can also help you make connections.
- The purpose of this grant is to fund **new** ministries, missions, or fellowship events. This does not mean something that's never been done before *anywhere*, but rather something new for this particular collective of congregations.
- If the proposal does not fall within the requirements and intent of this grant, CFY will be in conversation with you regarding possible revisions.
