In 1949, a group of twenty-five families, led by the pastors of Second and Lyndora Presbyterian Churches, formed a Sunday School in a rapidly growing area west of Butler. In June 1950, 100 people petitioned Butler Presbytery to organize a congregation in the area and a building site was purchased by the Presbytery. Three hundred people attended the first service in a rented tent; 115 were received as charter members of Trinity Presbyterian Church. In 1951, the original brick building was completed and by 1969, the congregation had grown and expanded into the newer mid-century modern building we now enjoy.

Our history just happens to be God's story. As congregations grow up and out of neighborhoods, that change is reflected in the mission of the church. The people change but God is the same yesterday, today, and tomorrow. Thankfully, God preserves a remnant of believers set aside for such a time as this. There came a time when difficult questions had to be answered. The only proposal refused to be considered was the one that would have closed the doors of Trinity church and revoked their charter. However, God's call is irrevocable.

Thanks to the discernment of the Presbytery and the Grace of God, we continue to seek God's will for this community and beyond. From our own neighborhood clothes and food pantry to the children of Northwest Elementary School to around the world at a hospital in India and a Compassion International child in Ghana. In addition to holding neighborhood Bible studies, we also offer our building as host to various outside organizations such as AA, Boy Scouts, Girl Scouts, quilters, and a senior musical program.

Our newest hope and prayer is the prosperity of a Presbyterian campus that presents traditional and contemporary worship. Two congregations giving the community a choice to worship whichever way they see fit, without giving up their Presbyterian roots. Being good stewards of God's provision is valuable, working together doing it is priceless!

We are in our sixth year being led by CRE Pastor Carmen Shullo Sr., living, laughing, learning, and loving. We continue to grow in numbers and faith, and we continue to look forward to a bright future, doing the work that God intended here since 1949.



#### From Zelienople:

Follow PA-68E for 15 miles; turn left onto S. Duffy Road for .2 miles. Turn right onto Staley Avenue. Church parking lot is on the left.

#### From Butler South:

Follow PA-8N into the city of Butler. From the County Courthouse take the third left turn onto W. Jefferson St./PA-68/PA-356. Keep right at the fork to Follow PA-356/New Castle Rd. In .8 miles. turn left onto S. Duffy Rd., then take the first left turn onto Staley Avenue. Church parking lot is on the left.

**From Butler North:** Follow PA-8S (about 8 miles south from Old Stone House) to right turn onto Mercer Road for about 1 mile. Turn right onto N. Duffy Road for about 2.3 miles. After crossing PA-356 at the traffic light, take the first left turn onto Staley Avenue and church parking lot is on the left.

#### XYZ CHURCH ANTI-RACISM POLICY

As followers of Christ, we are called to love our neighbor as ourselves (Matthew 22:39) and to fully embrace the truth that God equally loves and values all people (John 3:16, Romans 5:8, Galatians 3:28).

These New Testament passages rest on the foundation of the Old Testament. From the Pentateuch's outline of a covenant community built on pillars of justice and mutual responsibility to the prophets' fiery presentations of God's expectations and calls for fairness that echo through the Wisdom literature, the Old Testament reminds us again and again about God's call to full inclusion and equity.

Understanding racism and its traumatic effect on those who experience it is of paramount importance if divisive racial barriers are to be torn down and structural racism is to be dismantled.

Being guided by these Scriptures and in accordance with the Book of Order, our Session hereby adopts the following Anti-Racism Policy.

Racism is defined as: 1. The belief that race accounts for differences in human character or ability and that a particular race is superior to others. 2. Discrimination or prejudice based on race.<sup>i</sup>

The XYZ Church is committed to growing in our awareness of the presence of racism in our congregation and individual lives. We are dedicated to developing anti-racist behavior that restores the dignity of men and women and brings genuine unity to the Body of Christ.

Furthermore, we will work within our sphere of influence to eliminate racism wherever it may exist and in whatever form.

#### I. Introduction

XYZ Church strives to create and maintain an environment in which people are treated with dignity, decency and respect. Our environment should be characterized by mutual trust and the absence of intimidation, oppression and exploitation. Everyone should be able to work and learn in a safe, yet stimulating atmosphere.

The accomplishment of this goal is essential to our mission. For that reason, XYZ Church will not tolerate harassment of any kind. This Policy applies to all church members and staff and to all volunteers and independent contractors.

#### II. Prohibited Behaviors

Examples of behaviors that are unacceptable:

- Striking another person.
- Swearing or using profane language in normal conversation or when directed in a negative manner against another person or group.
- Expressing innuendo or gossip about another person.
- Unfairly and routinely criticizing the work of another, making undignified remarks to another employee or program participant, or saying things in a group discussion that are humiliating to another.
- Exhibiting a superior attitude, making threatening remarks, and engaging in intimidating behavior in order to make that person feel small.
- Making offensive or insulting statements to or about another person.

#### III. Education and Training

The education and training of those covered by this Policy will include but not be limited to the following:

- A. Providing a copy of this Policy to all staff, volunteers, and independent contractors.
- B. Training all pastors and staff on this Policy.
- C. Training all newly elected/ordained Elders, Deacons and Trustees about this Policy.
- D. Providing information to the congregation about this Policy and its procedures for identifying and reporting all types of harassment.

Violations of the Policy may be subject to the provisions of Church Discipline in the Book of Order.

#### **Explanation of the Paid Family Leave Policy**

The 225<sup>th</sup> General Assembly of the Presbyterian Church (USA) amended G-2.0804 of the Book of Order to require Presbyteries include a provision for a minimum of twelve weeks paid family medical leave, which includes but is not limited to: leave to accommodate the birth, foster placement, or adoption of a child, leave to provide care to an ill or disabled family member; and leave to heal following a loss or tragic event.

In accordance with G-2.0804, the congregations of Beaver-Butler Presbytery shall include a provision for a minimum of twelve weeks paid family medical leave in their pastor's terms of call.

#### **Eligibility**

All ministers of Word and Sacrament serving a PC(USA) entity and other full-time employees.

#### **Leave Parameters**

- Up to 12 weeks (total, regardless of precipitating event or circumstance) of Paid Leave per year, with as much advance notice as possible. Paid Leave may be used—in accordance with need—consecutively or intermittently.
- During Paid Leave, the pastor will continue to receive all benefits in their terms of call, including dues paid to and benefits provided by the Board of Pensions.
- Use of vacation time is not required but may be used to extend leave time at the discretion of the pastor.

Following the period of Paid Leave, the pastor shall be entitled to return to the same position with the same title, terms of call, hours worked, and job description.

#### **Types of Leave**

- Parental Leave: Within one year of birth or adoption, a pastor may take up to twelve consecutive or intermittent weeks bonding time.
- Caregiver/Family Leave: In times when a family member requires care due to an illness or disability, a pastor may take up to twelve weeks Paid Leave, either consecutively or intermittently, depending on the nature of illness and need.
- Personal Loss: In the event of the death of a loved one or a tragic event, a pastor may take up to twelve weeks Paid Leave, either consecutively or intermittently, depending on the nature of event and need.

#### **Church Support**

- While the individual church/entity is responsible for the funding and administration of Paid Family Leave, state-provided disability and paid leave benefits and Board of Pensions financial protection programs may be considered in order to help offset income continuation costs.
- Where possible, communication of mutual needs and planning is vital to minimize disruption for the entity served by the pastor. Pastors are encouraged to anticipate leave with sensitivity around the needs of the church/entity/body, including but not limited to temporary replacement and fulfillment of duties.

Randall referred the Presbyters to his written report. The 2023-2025 *Book of Order* is now available for ordering; bulk orders are now being taken. He also noted recent changes in the Constitution, and stated that the Clerk's office is preparing resources for responding to these changes.

#### **EXECUTIVE PRESBYTER REPORT:**

Rev. Dr. Tom Harmon

Rev. Dr. Thomas Harmon gave an enlightening report on churches that conclude their ministries and close their buildings. What will happen to those buildings, and will they be used for *good?* Tom suggests that instead of being closed forever, the Holy Spirit can intervene, and the buildings can end up being closed for *good* (a play on words!)

Tom highlighted the recent successful joining of two churches, Presbyterian and Lutheran, in Ambridge. The Presbyterians had no building, but a pastor, and Lutherans had a building, but no pastor! With patience and dedication, the two (formerly struggling) congregations are now worshiping together, facing a bright future.

Tom also noted a new program from the Board of Pensions, *Season of Rebuilding* – a discussion regarding changes to the medical plan. The goal of the *Season of Rebuilding* is to create affordable ways churches can add pastors to the Board of Pensions, focusing on providing more opportunities for women in ministry, small congregations, and congregations of color. #### PLAN OF AGREEMENT FOR A UNION CONGREGATION

So then you are no longer strangers and aliens, but you are citizens with the saints and also members of the household of God, built upon the foundation of the apostles and prophets, with Christ Jesus himself as the cornerstone. In him the whole structure is joined together and grows into a holy temple in the Lord; in whom you also are built together spiritually into a dwelling place for God. Ephesians 2:19-22

This Plan of Agreement is between the Zion's First Evangelical Lutheran Church and the United Presbyterian Church of Ambridge, both located in Ambridge, PA.

We come together as two congregations from different denominations, serving the same neighborhood, to more effectively serve Jesus Christ in the community of Ambridge. We commit to a covenant affirming the body of Christ beyond denominations. We commit to focusing on what unites us as believers and work to discover what the Spirit is guiding us to do and be. We commit to the care and nurture of faith and each other. We honor unique aspects of our particular congregation's history and denominational heritage. We currently find that we are no longer strangers but members of the same household, growing spiritually in a dwelling place of God. We are patient and thoughtful in our deliberation, respectful of our differences, and dispense with divisions and distractions so that together we can show forth the kingdom of God. We rejoice that the good news of salvation is ours to share.

- 1 PURPOSE: The purpose of forming a union congregation is to formalize the relationship between the congregations of Zion's First Lutheran and United Presbyterian so they become one functioning congregation. The members of these congregations engage in common worship, mission, ministry and fellowship. This document expresses the desire to extend this commonality to administration and governance in the form of a single union congregation.
- **2 PLAN FOR UNION:** Zion's First Lutheran and United Presbyterian agree to blend their ministries to form a union congregation to be known as TBD as set forth in this Agreement.
  - **2.1** This Agreement and the attached Bylaws of the Congregation shall be submitted to the Southwestern Pennsylvania Synod of the Evangelical Lutheran Church in America and the Beaver-Butler Presbytery of the Presbyterian Church in the United States of America for approval.
  - **2.2** This Agreement and the attached Bylaws of the Congregation shall be submitted to a duly announced joint meeting of the members of Zion's First Lutheran and United Presbyterian for approval. Approval requires a two-thirds vote of each congregation.
  - **2.3** Upon approval by the members of the existing congregations and the appropriate judicatories of the Synod and Presbytery, this Agreement shall be executed and delivered as follows:
    - **2.3.a** This union congregation shall cause a new corporation named TBD to form and all union congregation business shall be conducted under this new corporation.
    - **2.3.b** A new bank account shall open under the corporation formed in sub-paragraph 2.3.a.
      - **2.3.b.i** All union congregation church business, deposits to and expenses from this account.
    - **2.3.c** United Presbyterian Church of Ambridge and Zion's First Evangelical Lutheran Church shall transfer all property and assets to the corporation formed in sub-paragraph 2.3.a.

- **2.3.d** All assets of this union congregation, real and personal, shall be held by the corporation formed in sub-paragraph 2.3.a. All liabilities of the congregation in this union congregation shall be liabilities of this union congregation.
- **2.3.e** The Bylaws shall be adopted as the Bylaws of the TBD new name.
- **2.3.f** Upon completion of the transfer of all property and assets, Zion's First Evangelical Lutheran Church and United Presbyterian Church of Ambridge shall dissolve.
- **3 MEMBERSHIP:** Members of the Zion's First Lutheran and United Presbyterian become members of the union congregation.
  - **3.1** Members of the United Presbyterian Church retain their Presbyterian designation. Members of Zion's First Evangelical Lutheran Church retain their Lutheran designation. Both are members of the union congregation.
  - **3.2** New members join the newly formed union congregation without designation of Presbyterian or Lutheran unless specifically requested. See the Bylaws for new member and confirmation for details.
  - **3.3** Voting members are on the active roll of the union congregation.
  - **3.4** Only members of the union congregation may serve on the Board.
- **4 CLERGY:** The clergy may be either a Presbyterian Church USA or Evangelical Lutheran Church of America ordained pastor in good standing with the PC USA or on the roster of Ministers of Word and Sacrament of the ELCA and approved for service to the congregation by both judicatories.
  - **4.1** The ordained minister, serving under appropriate call or contract in accordance with the procedures established by both the Presbytery and the Synod, shall be responsible for the pastoral oversight of this union congregation as outlined in the job description, found in the bylaws under staffing.
  - **4.2** The ordained minister shall be subject to the discipline of the denomination to which accountable, as prescribed in the constitution and bylaws of the denominational body in which the ordained minister is rostered or holds membership.
- **5 Union Congregation Governance:** The regular rules for governance of the union congregation shall be provided for in this Agreement and the Bylaws. The Bylaws may not conflict with this Agreement and this Agreement and the Bylaws may not conflict with the constitutions of the judicatories except as described in Section 5.4.
  - **5.1** There is one governing body for the union congregation satisfying the requirements set forth of the PCUSA Book of Order and ELCA Constitutions Bylaws and Continuing Resolutions. The governing body is called the Board. Rules for composition, election, and duties of the Board shall be outlined in The Bylaws.
  - **5.2** The Board shall ensure that all committees and organizations within the union congregation exist to support the ministry of Jesus Christ.
  - **5.3** Where applicable, the Board shall serve as directors of the corporation of the union congregation and shall be elected as provided in The bylaws.

- **5.4** This Agreement is intended to reflect the blended ministries of the PC USA and the ELCA. The parties in this Agreement acknowledge that the judicatories requirements may differ or conflict in some matters, including by way of example and not limited to, conduct of worship, calculation of membership and of assessments/apportionment, changes in status of the congregation, and structure of the governing Board.
- **6 OPERATIONS:** The union congregation is comprised of both Presbyterian and Lutheran members. The union congregation reports to and is guided by both the PC USA and the ELCA. The management of this relationship shall be provided for in the Bylaws under Article Operations.
- **7 DISSOLUTION OF AGREEMENT:** Dissolution of this agreement results in the dissolution of the union congregation set forth in the Bylaws under Article Dissolution.
- **8 AMENDMENT:** Once approved, this Agreement may be amended, provided that any such amendment be approved by a majority of the Union Board and a majority of voting members of the Union Congregation present at a called congregational meeting.

#### **Bylaws of the Union Congregation TBD**

#### Article 1 Corporation

- **1.1.** The Union Congregation is incorporated under and does business as TBD and herein referred to as the Union Congregation. The Church physically resides in Ambridge, PA. The Corporation formed as an outcome of the Agreement for a Union Congregation between Zion's First Lutheran and the United Presbyterian church of Ambridge.
- **1.2.** No Officer acting for this Church shall be personally liable for the debts, liabilities, or obligations of the Corporation.
- **1.3.** The annual meeting of the Corporation shall be held simultaneously with the Annual Congregation Meeting as described in Article 5.
- **1.4.** The Board (see Article 3) shall be elected yearly at the Annual Congregational Meeting as Trustees of the Corporation according to the laws of the Commonwealth of Pennsylvania. Responsibilities of the Trustees will be according to the Articles of Incorporation.

#### Article 2 Faith

2.1. The Union Congregation maintains denominational ties with the Evangelical Lutheran Church in America and the Presbyterian Church (USA). The Union Congregation subscribes to the recognized statements of faith and governing documents of both of these denominations. By including a community of people from different faith backgrounds and denominations, the Union Congregation is enriched by this diversity that deepens the sharing of a covenant relationship with the Triune God.

#### Article 3 Church Board

- **3.1.** The Church shall be governed by a representative body elected by the congregation from among its members. This governing body shall be called the Board.
- 3.2. The Board is the one governing body for the Union Congregation, satisfying the requirements set forth of the PCUSA Book of Order and ELCA Constitutions Bylaws, Corporation Standards of the Commonwealth of Pennsylvania, and Continuing Resolutions.
- **3.3.** There shall be six officers on the Board.
  - **3.3.1.** The existing session/council determines the nominations to present for the initial Board with a makeup of three Presbyterian and three Lutheran members. Terms will stagger across three years so that only two positions are required to be filled per year.
- **3.4.** Terms are 1-3 years with a limit of serving two consecutive 3-year terms.
- **3.5.** The Board elects a treasurer for the Union Congregation. This treasurer reports to the Board and presents a budget to the Board each October.

- **3.6.** The Board appoints a Clerk of the Board. The Clerk takes minutes at all Board meetings, Congregational meetings, and keeps the parochial records for each congregation. The Clerk prepares the congregation's annual reports and submits them to the appropriate church wide expression.
- **3.7.** The Board appoints its officers to chair the committees the Board itself determines are crucial for the operation of the Union Congregation. For example: Finance and Personnel, Building and Grounds, Hospitality, Congregational Care, Mission, Christian Education, Music and Worship.
  - **3.7.1.** Congregational Care committee performs the work of the former Board of Deacon. There is no longer an elected Board of Deacons.
- **3.8.** The pastor is the moderator for the Board.
- **3.9.** A quorum for the Board is defined as two-thirds rounded up to the next whole number of the current members, and is required before voting on any matter.
- **3.10.** Simple majority passes voting initiatives.
- **3.11.** Officer training takes place over the course of the year.
- **3.12.** PC USA polity will be observed in regard to election, ordination and installation to the office of the Board as a ruling elder. This process will begin in June with election of officers in October.
- **3.13.** Installation of officers takes place in January. As it is PC USA polity to ordain officers, officers who feel called will be ordained at the time of installation.
- **3.14.** Members of the Board can vacate their office by removal or resignation.

#### **Article 4 Nominating Committee**

- **4.1.** The Nominating Committee shall be comprised of four members and is elected each year at the Annual Meeting.
  - **4.1.1.** The two years following the formation of the union congregation, the Nominating Committee shall be comprised of two members with a Presbyterian designation and two members with a Lutheran designation.
- **4.2.** The Nominating Committee follows a set process of discernment (as agreed upon by the Board) and presents the slate of officers nominated for the Board to the congregation for a vote in October.
- **4.3.** Members of the current year Nominating Committee are not eligible for election to the Board.

#### Article 5 Meetings

**5.1.** An annual Union Congregational meeting takes place in October to elect officers and a meeting is held in January to present the Annual Reports of the past year's works and to present the new year's budget.

- **5.1.1.** Quorum is 10% of the Union Congregation's voting members attending in person or electronically.
- **5.1.2.** Majority of the attending quorum passes voting initiatives.
- **5.2.** Additional Congregational Meetings may be called as determined necessary by the Board or when requested in writing to the Board by one fourth of the voting members of the Union Congregation.
- **5.3.** Publicized notification of any Congregational Meeting is required. This notice shall specify the purpose, time and place of the Congregational Meeting. Notification of information shall occur by two weekly publications, starting at least two weeks prior to the meeting. Notifications shall occur during the worship service, verbally and/or in bulletin(s), on the congregation's website, and by email and telephone if possible.
- **5.4.** Depending on the situation, the voting members of the congregation can attend in person and/or via electronic technology, by means of which attendees can simultaneously participate in the meeting proceedings, speak or communicate electronically to submit comments or questions, and to cast a vote.
- **5.5.** The Clerk of the Board shall take minutes to record and preserve the records of the business that was conducted and the actions that were taken by the Union Congregation.

#### Article 6 Staffing

- **6.1. Minister** The minister may be either a Presbyterian Church USA or Evangelical Lutheran Church of America ordained pastor in good standing with the PC USA or on the roster of Ministers of Word and Sacrament of the ELCA and approved for service to the congregation by both judicatories.
  - **6.1.1.** The ordained minister shall be subject to the discipline of the denomination to which accountable, as prescribed in the constitution and bylaws of the denominational body in which the ordained minister is rostered or holds membership.
  - **6.1.2.** It is a requirement that the minister maintain a worship service of blended Presbyterian and Lutheran practices.

#### Article 7 Personnel

- **7.1.** The Personnel Committee shall be guided by the Board. It shall consist of two or three members.
  - **7.1.1.** Members of the committee are elected by the Board.
  - **7.1.2.** The chair of the Personnel committee is a member of the Board appointed for that ministry role.
  - **7.1.3.** The committee shall review job descriptions, current staffing, meet yearly with each employee to review and discuss performance and compensation. Members of the personnel committee will serve a 3-year term.

#### Article 8 Confirmation and New Members

- **8.1.** New member education and youth confirmation classes will encompass both Lutheran and Presbyterian history, creeds, theology and worship practice.
- **8.2.** New members join the Union Congregation without designation of Presbyterian or Lutheran unless specifically requested.

#### Article 9 Membership

- **9.1.** New members of the congregation shall be baptized persons who join in accordance with the practices and policies of the Union Congregation.
- **9.2.** Members of the former Zion's First Lutheran and United Presbyterian retain their denominational designation of Presbyterian or Lutheran Church as set forth in the Plan of Agreement for a Union Congregation in the Membership section.
- **9.3.** Membership shall be shared between the Evangelical Lutheran Church in America and the Presbyterian Church (USA).
- **9.4.** Voting members are on the active roll of the union congregation.
- **9.5.** Only members of the Union Congregation may serve on the Board.

#### Article 10 Operations

- **10.1.** The Board will create a Manual of Operations within the first year of forming a union.
- 10.2. The governing body of this union congregation shall report the membership of the union congregation based on member designation to the appropriate ecclesiastical entity of oversight. Such membership shall be published in the regular report of each church body involved with a note to the effect that the report is that of a congregation in a union congregation, and with an indication of the total actual membership. The same dissemination shall be used for the annual statistical/parochial reporting provided by the Clerk of the Board to the appropriate ecclesiastical entity of oversight.
  - **10.2.1.** Membership that does not designate Presbyterian or Lutheran splits 50/50 when reporting to the PC USA and ELCA. If it is an odd number, the remainder reports to both.
- **10.3.** Weekly financial offering funds the union congregation account.
- 10.4. Designated donations pass through the union congregation account and pay to the designation.
- 10.5. While recognizing the basic right of any giver to designate the cause or causes to which a personal gift shall go, the governing body of this union congregation shall annually propose to the congregation a general mission support or benevolence program for the synod and presbytery and churchwide efforts of each related church body. The proportions shall be as this congregation's governing body shall decide in response to the requests of the related ecclesiastical entities.

- 10.6. Per capita apportionments or assessments shall be paid to each ecclesiastical entity of jurisdiction on the basis of the collected amount and dispersed based on membership designation.
  - 10.6.1. Presbytery and synod set the per capita apportionments/ mission support formula. The union congregation publishes the higher amount and requests support from all members.
- **10.7.** Collected funds disperse based on the contributor's designated denomination; Presbyterian designation contributions go to Presbytery, Lutheran designation go to Lutheran synod, undesignated union congregation split 50/50 between the Presbytery and the Lutheran synod.

#### Article 11 Amendments to Bylaws

These Bylaw Articles and their provisions can be amended or certain articles and their provisions can be suspended by a two-thirds vote of a quorum of the Union Congregation as described in Article 5.

- **11.1.** The Board shall appoint a Bylaws Task Force, at least every five years, to review the Bylaws and provide recommendations, including proposed amendments. The Minister and Congregation can also provide recommendations to a Bylaws Task Force. The board shall study all recommendations from the Bylaws Task Force at a regular or special Board meeting.
- **11.2.** The Board shall present the proposed amendments and provide the Board's recommendation to the Union Congregation at a Congregational meeting as described in Article 5. Approval of any amendments must be by a two-thirds positive vote of the Congregation quorum as described in Article 5.

#### **Article 12** Emergency Provisions

- **12.1.** An "emergency" exists for the purposes of this section if a quorum of the Board members cannot be obtained because of some catastrophic event. Board action, taken in good faith during an emergency, binds the Union Congregation and may not be the basis for imposing liability on any Board members or Officers of the Corporation on the grounds that the action was not authorized.
- **12.2.** During an emergency, the Minister and/or Clerk of the Board will attempt to contact all Board members (in person, by telephone, text, and/or email) to provide them with the notice of the emergency.
- **12.3.** If an emergency meeting is called, the presence of at least fifty percent of current Board members is required to establish a quorum for voting purposes.

#### Article 13 Dissolution

- **13.1.** This union congregation may be dissolved by a two-thirds vote of two congregational meetings, held not less than one year and not more than two years apart, subject to the concurrence of the governing bodies of the Evangelical Lutheran Church in America and the Presbyterian Church (USA).
- **13.2.** Following the polity of the Evangelical Lutheran Church in America, all property shall be disposed of with the congregation selecting the beneficiaries of the proceeds.

#### **MVC Floor Action for Beaver-Butler Presbytery**

On examining ordained Ministers of the Word and Sacrament (Teaching Elders/Pastors) for membership in Beaver-Butler Presbytery.

For Action: The Ministry and Vocation Committee asks Beaver-Butler Presbytery to provide commissioning ability to 1) approve ordained pastors for membership in Beaver-Butler Presbytery; 2) provide for the installation of a pastor in connection with a congregation or validated ministry; 3) approve Terms of Call; and 4) ask for the creation of an installing Administrative Commission on behalf of the Presbytery.

#### Rationale and Information:

The MVC will use the following processes to discern and evaluate fit for installing a pastor in a call to ministry on behalf of the Presbytery.

- 1) Reference Check the prospective pastor in conversation with the current Presbytery of membership.
- 2) "Meet and Greet": Meeting between the prospective pastor and PNC by MVC task group.
- 3) Examination by the full MVC on behalf of the Presbytery: MVC will receive the prospective pastor's PIF/PDP, Statement of Faith, and Terms of Call in agreement with Session and PNC before its meeting.

MVC's discussion with the prospective pastor will include, but not be limited to, the following questions:

- a. What events or persons have significantly affected your ministry?
- b. What theological truths have emerged as critical to your practice of ministry?
- c. What experiences have challenged or affirmed your ministry?
- d. How do the sacraments influence your practice of ministry?
- e. What part does Scripture play in your ministry's practice, presentation, and application?
- f. How has the fellowship of the presbytery body helped in your ministry?
- g. With what or how can the Beaver-Butler Presbytery help you in the practice of your ministry?
- 4) With MVC's approval of the prospective candidate and Terms of Call and Membership in Beaver-Butler Presbytery, the session can provide a worship service of the welcome and call a congregational meeting to call the pastor formally and approve the Terms of Call.

- 5) Should the way be clear, MVC will provide a robust greeting to the new pastor at the next Stated Presbytery meeting by:
  - a. A record of actions taken by the MVC, as a commission, in approving the pastor for membership and the congregation's vote, along with Terms of Call.
  - b. The Presbytery shall approve an Administrative Commission for an Installation Service in the Consent Agenda.
  - c. Provide the approved pastor's Statement of Faith in pre-distributed meeting materials.
  - d. Introducing the new pastor with a description of their background and present church call.
  - e. Welcoming questions by presbyters as a means of introduction and getting to know the new pastor.
  - f. Invite presbyters to continue to greet the new pastor during any scheduled fellowship time in the Presbytery's meeting or an alternative time after the meeting.

She has worked as a social worker with many diverse and vulnerable populations in Palestine, the United Kingdom and the United States.

#### PROCEDURE FOR NOMINATING & ELECTING GA COMMISSIONERS & YAADS

#### **Eligibility**:

In order to be eligible for nomination, a teaching elder must:

- have been a member of Beaver-Butler Presbytery for at least three years;
- have session endorsement, if the teaching elder is serving a congregation;
- have attended at least half of the Presbytery meetings for the previous three years prior to October
   1 of the year before General Assembly meets; and
- be able to demonstrate active service in the Presbytery through its committees and/or units.

In order to be eligible for nomination, a ruling elder must:

- have been a member of a congregation within the bounds of Beaver-Butler Presbytery for at least three years;
- have the endorsement of his or her session;
- have attended at least two Presbytery meetings in the previous three years prior to October 1 of the year before General Assembly meets; and
- be a member of a church which has sent a ruling elder commissioner to at least half of the Presbytery meetings for the previous three years.

In order to be eligible for nomination as a Young Adult Advisory Delegate, a person must:

- have been a member of a congregation within the bounds of Beaver-Butler Presbytery for at least one year;
- be within the age range specified by the General Assembly for eligibility as a YAAD; and
- have the endorsement of his or her session.

Ruling and teaching elders may be elected as commissioners to two consecutive assemblies. A commissioner who has served at two consecutive assemblies shall be ineligible for election as a commissioner to the next General Assembly.

#### Timeline and Procedure:

The nomination process for GA commissioners and YAADs will be the responsibility of a task force composed of three former commissioners (elder and minister), beginning with the most recent assembly and continuing until all four positions are filled (elder Commissioner, Minister Commissioner, Alternate Commissioner and YAAD [if possible]). The timeline will be as *follows in the year before a General Assembly meeting*:

- <u>Task Force Selection</u> The Coordinating Team will identify the task force members and select the convener from its members by **March**.
- <u>Search for Candidates</u> The task force will begin actively publicizing the opportunity for to apply for nomination no later than the **May** Presbytery meeting.
- <u>Deadline for Candidates to express interest</u> Those seeking to be nominated are asked to express their interest to the task force by **August 31**.
- <u>Deadline for Submission of Questionnaire</u> Candidates for nomination will complete and submit a questionnaire to the task force by **September 30**.
- Review & Interviews The task force will convene in **October** to review the candidates' information and determine if interviews with the candidates are necessary. This determination will be made by, among other things, the number of candidates under consideration, familiarity of the candidates to the task force members, and clarity of the candidates' responses to the questionnaire. If the task force determines that interviews are necessary, these interviews will include all applicants.
- <u>Presentation of Nominations</u> After prayerful consideration, the task force will present its nominations to the Presbytery at its **November** meeting, so that the elected commissioners and

YAAD may be reported to the Stated Clerk of the General Assembly at least 180 days prior to the Assembly, as required by the Standing Rules of the General Assembly.

The General Assembly commissioner nominating task force will present one nomination for each commissioner position and one alternate position. These nominations will serve as the recommendations from the task force, based upon their diligent and prayerful consideration of the candidates. Any former commissioner serving on the task force who has applied to be nominated for the next consecutive G.A. shall recuse his/herself from his/her own consideration.

The report of the task force will be made available before the November Presbytery meeting and will include the names and questionnaire responses of the nominees, as well as the names of all those who were considered.

Nominations from the floor, including candidates considered but not recommended by the task force and others who were not part of the selection process, may be made with the consent of the nominee and on the condition that the nominee meets the eligibility requirements of this policy.

If there are more nominations than positions available, a secret paper ballot will be conducted. Nominees must receive a majority vote in order to be elected. Separate votes will be conducted for the ruling elder, teaching elder, and YAAD nominees.
