

North Sewickley Presbyterian Church




On August 6, 1846 a group of men and women met under an old oak tree located near the North Sewickley Cemetery on Chapel Drive, and officially organized the North Sewickley Presbyterian Church. Native timber for the building was felled and cut into finished lumber at a local saw mill. Workers hand planed the flooring and finish boards, one-piece beams made the building support.

In May of 1934, to increase building space, the men of the church used teams of horses, tractors, scoops and shovels to remove dirt from under the church to create a basement. A belfry was added to the building, and the bell was joyously rung for the first time in 1938.

Continuing to outgrow the facility, a committee was formed in the fifties to consider the options of enlarging the existing building. The committee advised against modifying the original structure, and instead recommended purchasing property and moving to another site. This resulted in the purchase of slightly over eight acres from the Connoquenessing Country Club, and on March 11, 1961, ground was broken for the present worship location of the North Sewickley Presbyterian Church.

September 25, 1961 marks the date that the cornerstone was laid, and on November 4, 1962 the congregation celebrated their first worship at the new location. The building was dedicated in March 1963, and remarkably, the mortgage was burned only eleven years later in November of 1974.

Ground was broken in 1977 for the current manse, 131 years to the day of the signing of the original church charter. Within a year, the congregation's Pastor and his family moved into the new manse. The 1980's were a time of growth for the church.



The authentic bell from the first building was installed on the present church grounds in August 1988. In 1993, a picnic pavilion was erected in the woods of the church property, and many fine experiences have been shared in a pavilion whose roots sprouted from a faithful few of Christ's followers under an old oak tree.

During the 2000s several projects led to a gabled roof over the Christian Ed building, new windows, accessible bathrooms and re configured office area. The sanctuary and offices were also air-conditioned. Our parking lot was paved and lined to add convenience. Our neighbors use our paper-recycling bin and a clothing drop as well.



In 2016 a new entryway and reception/gathering area along with a handicapped accessible entrance was added below with a full-size elevator. Our new kitchen is almost twice the size of the former one; many events and community functions make use of this space.

This history of our building is interesting but the Lord has used the folks who worship here for much more. We support each other, and our community. We help the Pine Valley camp, down the road that ministers to inner city children from the Pittsburgh area. Each year there is a large rummage sale to raise funds for local causes. Members give their time and money to various community organizations.

North Sewickley not only supports mission through our Presbytery and PCUSA, we partner with Christians in Miraj, India; Uganda; Kenya; Tanzania and South Africa. Members have gone on numerous mission trips to these locations, as well as P.D.A. missions in the USA, and other local missions.

NSPC is an active congregation with a history of "knowing Jesus and making Him known" in North Sewickley Township for 175 years and counting. North Sewickley Church is currently served by the newly installed pastor, Rev. Dr. Rebecca A. Kahnt, known as Pastor Becky.

A GATHERING OF THE CHURCHES OF BEAVER-BUTLER PRESBYTERY November 14, 2023, 6:00 PM

Hybrid Meeting – In-Person & Zoom

The Beaver-Butler Presbytery held a stated meeting at 6:00 PM on Tuesday, November 14, 2023, using a *Hybrid* format: in-person and Zoom technology. The meeting was held at New Salem Presbyterian Church, Midland, where Jeffrey R. Marquis serves as Commissioned Pastor (CP).

Presbytery Moderator Elder Carolyn Paulsen called the meeting to order at 6:00 PM and affirmed the presence of a quorum with Stated Clerk Rev. Randall Clow.

WELCOME, ORIENTATION, AND OPENING WORSHIP:

Moderator Paulsen welcomed Minister Members, Elder Commissioners, and visitors. Carolyn took a moment to familiarize those attending on Zoom how to interact with the meeting.

WELCOME FROM THE HOST CHURCH:

Elder Sherbe Zorich welcomed the Presbyters and gave details of the facility, including fellowship location. She also gave a brief overview of New Salem's history.

WELCOME OF NEW ELDERS AND CORRESPONDING MEMBERS:

First-time Ruling Elder Commissioners were introduced.

Moderator Paulsen opened the meeting with prayer...

ANTHEM / SPECIAL MUSIC: "Refiner's Fire" New Salem Choir

CALL TO WORSHIP:

The Worship time began with a Responsive Call to Worship

THE WORD READ: Luke 12:1-7

THE WORD SPOKEN: "The Message to the Disciples" CP Jeffrey Marquis

Pastor Marquis opened with a reading from Luke12, Jesus speaking to the Disciples and the crowds – "Be on guard against the yeast of the Pharisees" – hypocrisy. Jesus tells his listeners to not be afraid. Indeed, a hard teaching, but Jesus telling us whom to fear, then telling us not to be afraid. Jesus' words follow a confrontation with the Pharisees, speaking of hypocrisy – *knowing what to do, and not doing it!* God's will for us is to not be a hypocrite.

Jeff gave a humorous example of how the "leaven" works its way into our lives, until it takes things over. But on a more serious track, he spoke of how we are to *fear God*.

GOOD NEWS FROM THE PEWS:

Commissioners offered items of good news that were happening in the churches, as well as various Announcements.

STATED CLERK REPORT:

Rev. Randall Clow

Randall referred the Presbyters to his written report, and explained the process for the *Second Reading – Process to receive New Members*, to be presented under Ministry & Vocation. He reminded the Commissioners that there were only two open meeting dates for 2024 Meetings – January and September.

EXECUTIVE PRESBYTER REPORT:

Rev. Dr. Thomas Harmon

Tom opened his remarks with the news that the Coordinating Team (CT) has decided, beginning January 2024, all Commissioners (and others wishing to actively participate in the Presbytery meeting) must be present at the meeting. Those joining remotely may do so via a Zoom link, but may only listen and watch. They will not be able to participate – voice or vote. As we have come out of the pandemic, in-person attendance has increased, while remote attendance has declined. Additionally, we have faced many challenges regarding remote participation, including voting. Concerns and questions may be addressed to CT Chair Andrew Why or anyone from CT.

Tom's comments focused on the well-known fact that we are in a time of change. Church membership and attendance are undergoing huge changes – indeed, overall church membership is half what it was two decades ago. Contemporary America simply isn't set up to promote mutuality, care, or a common life with others. Instead, life now is designed to maximize individual accomplishment as defined by professional and financial success.

However, many smaller churches are thriving because they have a Spirit-driven vision for the future. God has called us into God's future, and likewise, our faithfulness becomes the fruit of waiting and watching, holding fast as proclaimers of good news. We are building a faithful community.

Essentially, the games "...took a few jabs" at being Presbyterian. The questions (and answers) enabled us to humorously look more closely at ourselves. Besides getting to know the participants a bit better, everyone enjoyed the games!

MISSION & COMPASSION MINISTRY UNIT (MCM):

Rev. Dr. Judy Angleberger

- 1. Rev. Joshua D. Heikkila, West Africa Regional Liaison, Presbyterian Church (U.S.A.): Using a series of slides, Josh talked about his work in West Africa, Ghana in particular. He spoke about the differences in landscape, vegetation (and non-vegetation), and commerce across Ghana.
- 2. Pastor Jeff Marquis, sharing the mission of New Salem Church: Jeff spoke about New Salem's Missions that are done within the various communities of the church.
- 3. Pastor Tim Casey, Mt. Pleasant, Darlington, referred the Commissioners to a letter in the packet, and spoke about mission work at the Beaver County Jail.
- 4. MCM Chair Rev. Dr. Judy Angleberger noted an upcoming Matthew 25 Summit Meeting in Atlanta GA, January 16-18, 2024. MCM is offering financial support to those wishing to attend.

2. Examination of Rev. James W. Gear (Presbytery of Redstone):

MVC Chair Goossen moved that, if the way be clear, the Presbytery concur with the call of the Rev. James W. Gear as Transitional Pastor at the Concord, Hooker and North Washington Churches, and receive Rev. Gear as a member of BBP, effective January 1, 2024. (Note: As this was a contract position between Rev. Gear and the churches, MVC *approved the contracts.*)

Bob opened the questioning for Jim. After acknowledging Jesus Christ as Savior, he was asked to articulate his sense of call to Concord / North Washington. Some additional questions were offered from the floor. After questioning, Jim stepped out of the meeting.

Jim returned to the meeting (with applause!), and Bob offered a prayer for him and the churches.

Bob discussed the background and justification for behind the motion. After various questions and comments on the motion, the Vice-Moderator declared the discussion to be concluded, and proceeded to call a vote on the Motion.

Beaver-Butler Presbytery is a covenant community of churches that supports, nurtures, and helps grow disciples in the way of Christ.

Three-to-Five-Year Objectives:

- A. **Build increased engagement** of church members' participation in their local church and the Presbytery, which partners with their congregation's ministry.
- B. **Decrease barriers** between congregations and increase participation in joint ministry events to build trust-based relationships.
- C. **Equip leaders** to increase each congregation's ability to grow disciples in their relationship with God, empowering the church's faithful witness to its neighborhood.

One-Year Goals Working Toward Objectives:

- A. **Build increased engagement** of church members' participation in their local church and the Presbytery, which partners with their congregation's ministry.
 - i. Create a year-long plan of Presbytery meeting activities focusing on a shared future where churches equip and collaborate in ministry.
 - ii. Complete a new Presbytery brand identity, including logo and document appearance for communications from the Presbytery.
 - iii. Align staff toward one-year objectives through the employee review process to the annual CT goals.
 - iv. Update the Operations Manual, Bylaws, and Standing Rules for a first reading at the May Presbytery meeting.
 - v. Align the Presbytery's policies and procedures with the Mission Statement with changes for approval by the November Presbytery meeting.
- B. **Decrease barriers** between congregations and increase participation in joint ministry events to build trust-based relationships.
 - i. Facilitate at least four meetings for joint geographical conversations to identify similar congregational needs for an adaptive future ahead.
 - ii. Use the Congregational Connections Grant to help connect at least four joint ministry programs effectively.
 - iii. Facilitate conversations that invite at least two joint mission opportunities between congregations.
 - iv. Appoint a Task Force to plan for a future of repurposing of buildings and cemetery stewardship.

- C. **Equip leaders** to increase each congregation's ability to grow disciples in their relationship with God, empowering the church's faithful witness to its neighborhood.
 - i. Develop a task force to encourage Ruling Elder participation at Presbytery meetings and communication with their congregations.
 - ii. Expand knowledge of administrative best practices through an annual leadership event.
 - iii. Facilitate quarterly conversations among pastors and church leaders to consider best practices of churches' needs to help grow disciples in a changing time.
 - iv. Increase financial awareness, connecting the Presbytery's purpose to our support of congregations through the annual Narrative Budget and quarterly Per Capita materials with invitations to speak with at least three Sessions that do not pay Per Capita.
