Church History

Calvin Presbyterian Church was originally founded under the name, Zelienople-Harmony United Presbyterian Church, in 1845 by four families of Scottish descent. They were living in a community of German immigrants. When the church was established there were a number of Lutheran churches, several German Reformed (some that spoke English in worship, and others that spoke German), as well as Mennonites and remnants from the Harmonist movement in Harmony.

These four families hoped to create a church reaching out to those who felt different from the surrounding community, and who didn't feel like they fit into the dominant church culture. The church began to grow, and the original building was built in 1854. That original structure still stands, but it is now our Fellowship Hall. The sanctuary was built in 1901, and a major expansion was done in 1954. The name was changed to Calvin Presbyterian Church in 1959, at the request of the presbytery, because of the union of two Presbyterian denominations that led Park Presbyterian Church to be in the same denomination.

In 1998 the church did a major renovation of its sanctuary, with the goal of having a traditional look and feel, but with contemporary church attributes in sound, musical instruments, lighting, and more. In 2007, Calvin Church underwent a major renovation and expansion, which included everything but the sanctuary, adding classrooms, offices, meeting rooms, bathrooms, and renovating Fellowship Hall.

Calvin Presbyterian Church has also been blessed by a history of long and stable pastorships. The Rev. Dick Anderson was pastor at Calvin Church for 18 years, ending in 1994, and then, the Rev. Dr. Graham Standish, was for 20 years. The Rev. Connie Frierson blessed Calvin with her spirit and compassion from 2010 to 2021. Rev. A. David Paul was called to be Calvin's new head of staff in December 2019, yes, a few months before the COVID-19 Pandemic.

Since 1996 the church has more than doubled in size and attendance. The church's purpose and mission remains much the same as the original purpose and mission of the church, which is to reach out to people who are looking for a spiritual family that will accept and love them, no matter who they are or what their lives have been like.

Calvin Church has an approach that emphasizes our relationship with God the Trinity, teaching members how to become more radically open to God's purpose, Christ's presence, and the Spirit's activity in their lives. It emphasizes prayer and discernment, while also embracing the arts and music. Calvin Church has a wonderful and diverse music program, offering worship music that ranges from classical to contemporary, jazz to blues, and everything in-between.

Thanks to the sound foundation God built at Calvin, the steadfast faith and support of her members, and her creative and innovative staff, Calvin has grown in attendance, giving and ministry through the challenging years of the Pandemic (2020-2024). We've been blessed to expand upon Calvin's ministries by adding hybrid/digital ministries that average interaction with as many online as in person and thus far in 2024 is averaging 230 per Sunday across 16 different states and 3.25 countries! We are humbled by this new thing God is doing that we call Digital/Hybrid Ministry. We are thankful we stumbled upon it. And we have a lot of hope for the new future into which God is calling us!



Calvin's *"Season of Love"* concert/youth mission fundraiser packed Calvin's sanctuary with as many as we have had in two years. We had nearly twice as many attend online as in person and from 12 states coast to coast. The concert raised as much as in a normal book musical year, and as much was donated online as in the offering plate (half from online non-members)! And yes, under the PC(USA) quilt, that's a TUBA!

Throughout her history Calvin Church has been a church that seeks to do what God is uniquely calling us to do. Or in *'Presby-speak,'* Calvin embodies the great motto of the Reformation, *"Ecclesia Reformata, Semper Reformanda":* the church reformed and always reforming.

Directions to the Church:

Calvin Presbyterian Church is located right on Route 68, which connects Butler and Beaver. To get to the church get onto Route 68, and you will find Calvin Church

From the North and Northeast:

Get on Route 68 and travel south.

- If you are coming down 68 from Butler, you will find Calvin Church on the left approximately a mile and a half after you cross under Route I-79
- If you are coming down 1-79 from the north, you will get off at the Zelienople exit. You will take a right at the end of the ramp, and at the



"T" intersection with Route 19, you will take a left. At the traffic light, you will take a left onto Route 68, and Calvin Church is approximately four blocks on the right.

From the South and Southwest:

Get on Route 68 and travel north.

- If you are coming up 68 from Beaver, take a left to stay on 68 at the intersection with Route 19, which merges to become Routes 19 and 68. At the second traffic light, take a right onto Route 68, and Calvin Church is approximately four blocks on the right.
- If you are coming up I-79 from the south, get off at the Zelienople exit. Take a left, and Calvin Church is approximately one and a half miles on the left.

A GATHERING OF THE CHURCHES OF BEAVER-BUTLER PRESBYTERY January 27, 2024, 10:00 AM

The Beaver-Butler Presbytery held a stated meeting at 10:00 AM on Saturday, January 27, 2024. The meeting was held at North Sewickley Presbyterian Church, Ellwood City, where Rev. Dr. Rebecca A. Kahnt serves as Pastor. The meeting was held in-person and via *NON-INTERACTIVE* Zoom.

The meeting opened with "Holy Forever" from the North Sewickley Praise Team.

Presbytery Vice-Moderator Elder Dennis Krebs called the meeting to order at 10:05 AM and affirmed the presence of a quorum with Assistant Stated Clerk Rev. James Steiner.

WELCOME AND ORIENTATION:

Vice-Moderator Krebs welcomed Minister Members, Elder Commissioners, and especially visitors attending the Annual Memorial Service. He offered condolences to those who had lost loved ones in 2023 and opened the meeting with prayer.

THE WORD SPOKEN: "WORTH REMEMBERING"

Andrew opened by commenting on the previous term used to describe the Service of Remembrance, *Necrology Service*. This service is more than just a reading of a list of names. To illustrate his point, Andrew read from John 11, the account of the death of Jesus' friend Lazarus. Andrew spoke of the various times Jesus himself dealt with grief. For example, when John the Baptist was executed, Jesus went away by himself to grieve, reflect, and pray.

Every day, we are faced with challenges – hopefully, when faced with obstacles, we turn to God. However, oftentimes we blame God for not being there – we admit we just want to stay in bed and hide. In every case, Jesus says to us what he said to Martha and Mary: "I am the resurrection and the life…"

It's hard to understand life without first understanding death. There are everyday deaths, but there are times when we are *living* a life of death – going through the motions, merely plodding through life. Andrew used the film, *Groundhog Day*, to illustrate this point. Indeed, some things never change, but we must be ready to face whatever comes our way. Many times, we don't even realize how "dead" we are! Over time, we become frustrated with our lives. Those of us who live a "dead life" don't even realize we are in such a life.

Jesus offers us a NEW LIFE – an actual resurrection to a new life. Like Martha and Mary on the death of their brother Lazarus, we can cry out to Jesus. As Jesus called to have Lazarus to exit the tomb, he calls out to us as well. But just as Lazarus had the odor of death, so other things wrap around us – we have the same odor. Jesus unwraps us from these "smelly" things. Jesus is calling us to come out of the tomb and live a new life of faith.

Vice-Moderator Krebs offered a word of prayer, honoring those to be recognized during the Memorial Service.

ANNUAL MEMORIAL SERVICE

Vice-Moderator Krebs and Coordinating Team Chair Elder Andrew Why read the names of Ministers, Ruling Elders, Deacons, and Trustees who had entered the Church Triumphant in 2023. The reading of the names was interspersed with various Scripture passages of comfort.

Vice-Moderator Krebs closed the time of recognition with prayer.

BUSINESS MEETING

WELCOME FROM THE HOST CHURCH:

Elder Kathy Liller from North Sewickley welcomed the Presbyters and gave details of the facility, including fellowship location.

WELCOME OF NEW ELDERS AND PASTORS:

First-time Commissioner Elders were introduced.

Motion: To form the roll – seeing no objections, the Vice-Moderator declared the motion passed.

GOOD NEWS FROM THE PEWS:

Several Commissioners offered items of good news that were happening in the churches.

STATED CLERK REPORT:

Filling in for Stated Clerk Rev. Randall Clow, Jim referred the Presbyters to the written report – some highlights:

Rev. James Steiner

- Clerks are reminded to submit their Annual Statistical Reports.
- Leaders who have not renewed their 5-year Background Checks are reminded to do so.

EXECUTIVE PRESBYTER REPORT:

Rev. Dr. Thomas L. Harmon Tom opened his remarks with a brief re-telling of Jesus' Parable of the Two Sons, focusing on the two sons and the father. He spoke about the various ways to interpret the parable:

- The father's softening heart towards the Prodigal;
- The visible act of redemption;
- Grace abounds no matter the sin;
- The cultural background that prohibited the father from meeting the Son instead the community would meet him.

Instead, the father runs out to meet his lost son! The Greek is quite specific describing the father's actions – he actually *runs* to meet his lost son, using the same pace as a sprinter.

To provide background, Tom used a rather humorous "statistic" that only fifteen percent of men over Presbytery Meeting Minutes January 27, 2024 Page 2 of 8

forty will ever sprint again for the rest of their lives! He used his own recent return to ice hockey to support his point.

But with the father, it's an overwhelming moment of emotional compassion, to be sure. I we had been spectators looking on, we would have seen a man past sprinting age, running as fast as he can, out of breath and gasping for air, with sweat pouring from his brow, wrapping his arms around his boy and kissing him.

But isn't that what love looks like? In the church, we do a bunch of things, many of which are not understood by the world around us. We can be messy, and inelegant, and, at times, downright clumsy in the day-to-day work of ministry.

Like many men over forty, and like the father, our calling as the church is not to perfection or flawlessness. We muddle through, muck about, and keep going because we go in the direction of the one whose voice invites us to come. And we go, knowing that, at times, we may not go at a gazelle's pace or with a swan's beauty. But we will go faithfully, joyfully, into God's future because we're the church. We're the church together.

Cranberry Community United Presbyterian Church. Various Workshops will be offered for multiple aspects of church ministry, administration, and outreach.

COLLABORATION, FELLOWSHIP & YOUTH MINISTRY UNIT: Rev. Brian Hauser Brian reminded everyone of the Collaborative Grants that are available to churches who, in partnership with other churches, do something new together. The Unit wants to give churches free money to do good things! He reminded youth and youth leaders about the upcoming Youth Triennium, July 28-31, Louisville KY.

Presbytery Communications Assistant ChrisAnn Goossen took a few minutes to introduce herself and describe her work and responsibilities – website, Presbytery Newsletter, and the Resource Center.

MISSION & COMPASSION MINISTRY UNIT:

Rev. Dr. Judy Angleberger North Sewickley Pastor Rev. Dr. Rebecca Kahnt spoke about the church's history, and its connection to the various Native Nations that came before. North Sewickley Elder Pat Vagias discussed their mission in Uganda providing water resources to outlying communities. Judy reminded churches interested in pursuing a Mission Trip can access a "Tool Kit" from the denomination.

COORDINATING TEAM PRESENTATION – OBJECTIVES AND GOALS:

Using a lively skit, representatives from the Coordinating Team highlighted the CT's 2024 Goals & Objectives.
