#### **History of Clinton Presbyterian Church**



A group of God-fearing men and women held a meeting in 1845 to discuss the possibility of organizing a church. Rev. Isaiah Niblock and two elders met to organize the Union Associate Reformed Church. The rugged pioneer way was reflected in Rev. Niblock traveling to church on horseback once a month from Butler sometimes with his wife and children in tow. The name was later changed to the Clinton United Presbyterian Church in 1861 probably taken from the township

name. The log church was replaced by a frame structure. Many individuals still recall digging the basement with shovels, wheel barrows and horse teams hauling the dirt away to add a social room in 1938. The church was remodeled and rededicated in 1960 to its present structure.

Clinton Church has always been known as a Mission based singing church. Local and International Mission and Outreach projects have included Mission Aviation and various missionaries over the years. Today's mission projects include Food Bank, Operation Christmas Child and Heifer International. Several members have done mission work in Brazil, Slidell Louisiana and Covington Virginia as we continue to pursue the great Commission. Events are held throughout the month to provide fellowship for all age groups including Youth outings, monthly luncheons and events after worship. Although we are a small congregation, we accomplish a lot through our dedication in service.

We are blessed to have Rev. Kelley Angleberger as our pastor since 2016. She attended Princeton Theological Seminary and provides leadership and enlightening messages each Sunday. Pastor Kelley and her husband, Rev. Dr. Tom Harmon and five children, Austin, Clare, Abigail, Shepherd and William, all reside in Cranberry Township. We always enjoy seeing the entire family join us for events. Many changes have occurred over the last 179 years, but the unchanging truth of God's Work remains constant.

#### B. Floor Action:

1. At the East Unity Presbyterian Church congregation's request, Beaver-Butler Presbytery will appoint an Administrative Commission to assume original jurisdiction over the East Unity Church Session to complete the congregation's ministry and dissolve the congregation as of July 11, 2024. The AC will have five members and a quorum of three appointed by the Presbytery's Moderator following G-3.0109 in the *Book of Order*. The Presbytery gives the East Unity AC and the Coordinating Team the responsibility to act on its behalf in negotiations and property transfers. #### A GATHERING OF THE CHURCHES OF BEAVER-BUTLER PRESBYTERY May 28, 2024, 6:00 PM

The Beaver-Butler Presbytery held a stated meeting at 6:00 PM on Tuesday, May 28, 2024. The meeting was held at Concord Presbyterian Church, Baden, where Rev. Jamie L. Fowler serves as Pastor. The meeting was moderated by Presbytery Moderator Rev. Jamie Fowler and Vice-Moderator Elder Dennis Krebs.

Before the meeting, training was held for new Elder Commissioners (or anyone else wanting a refresher). Future meetings will have similar training sessions.

Moderator Fowler called the meeting to order at 6:01 PM and affirmed the presence of a quorum with Stated Clerk Rev. Randall Clow.

#### WELCOME FROM THE HOST CHURCH:

Elder Jeff Fowler from Concord welcomed the Presbyters and gave details of the facility, including fellowship location. Jeff also presented a brief history of the congregation and surrounding community, especially various Native American peoples.

#### **WELCOME OF NEW ELDERS:**

First-time Ruling Elder Commissioners were introduced.

#### **OPENING PRAYER:**

Moderator Fowler opened the meeting with prayer

**GATHERING HYMN:** "Here in This Place"

**THE WORD READ:** Acts 1:1-11 Elder Betty Kmiecik

#### THE WORD SPOKEN: Rev. Jamie L. Fowler

Referring to the well-known opening account in Acts, Jamie asked the question, "If we are empowered by the Holy Spirit, why do we sometimes stand around asking why the church ain't what it used to be?" Why do we suffer from fear and anxiety?

We are "Easter People," called to share the love of Christ. In the passage, we are reminded of Jesus' forty days of teaching and leading, done so before he was taken up. And now, the time had come for him to ascend to the Father.

Jesus promised the power of the Holy Spirit – essentially, "we are done, but not yet…" We want Jesus to restore the Kingdom, but not yet. But Jesus reminds them, and us, that the timing is the Father's, not us. We are to wait on the Spirit, and he will come, and we will receive the power.

We are not to "stand around" waiting for Jesus to return – our work is to restore the Kingdom until he returns.

#### **GOOD NEWS FROM THE PEWS:**

#### STATED CLERK REPORT:

Rev. Randall Clow

Randall referred the Presbyters to the written report, and explained the process by which a Presbyter may remove items from the Consent Agenda. #### International Peacemaker from Moldova to Visit in September



Dumitru Roibu is Executive President of YMCA Moldova. His history of YMCA community service includes roles such as World YMCA Youth Empowerment assistant and YMCA Change Agent (a global leadership program), and participation in YES (Youth Engagement in Sports) and TTT (Training The Trainers) seminars. Since the beginning of Russia's full-scale invasion of Ukraine in February 2022, Dumitru Roibu has been involved in supporting Ukrainian refugees fleeing the war. To date, helping more than 14,000 refugees, YMCA Moldova has created more than 320 Digital Educational Centers.

In 2013, Dumitru founded a rural youth NGO which supported cultural youth events, such as teaching folk dances. His NGO empowered more than 150 young people from the area to take part in Erasmus+, a European Union program for education,

training, youth, and sport. For his exceptional civic service, Dumitru was awarded the Civic Merit Medal in 2018 by the President of the Republic of Moldova.

Dumitru studied International Relations, has a master's degree in Diplomatic Studies and is currently working on his PhD in Good Governance.

#### My Time at GA

My time at General Assembly 226 was a fun, fruitful experience to take part in the life of the church. Before I begin, I'd like to thank my family, friends, and all members of the Beaver-Butler Presbytery for their endless support and prayers throughout the entire process.

General Assembly 226 (GA) held many important decisions to be made in the life of the church, most notably was the decisions concerning POL-01. POL-01 was a two-part motion, the first part of the overture added "gender identity" and "sexual orientation" to a list of named groups to emphasize a commitment to diversity regarding participation and representation.

The second part of the overture states that the statement about participation and representation must be considered when discerning ordaining someone to an office of the church. That candidate is not entirely bound to the Book of Order but can share their personal belief and still be ordained with the Council's approval. The effect is essentially the same, with a new written emphasis on conversations about participation and representation to change the book of order in a way that included all members of the LGBTQ+ community. After much deliberation, the General Assembly came to a compromise between the LGBTQ+ community and the PCUSA. Members of the LGBTQ+ community were included in the fold of the PCUSA, however, pastors being considered were allowed to maintain their personal beliefs as POL-01 was amended in order to preserve both sides of the compromise.

Much time was also spent debating order of business ENV-02 which concerned the possible divestment of funds from fossil fuels, oil, and gas companies. Arguments were made that pulling funds would state the church's stance against pollution while other arguments were

made that maintaining the funds would keep the PCUSA in negotiations with their affiliated companies to pressure them to change. The motion would change hands between passing and failing before finally settling to maintain the church's investments in ENV-02.

While much time was spent in sincere, prayerful consideration and debate, GA wasn't afraid of a little fun! Bathroom breaks became impromptu dance breaks as the electric slide and cupid shuffle would play in the assembly hall! Humor was also infused as the moderators weren't afraid to joke in-between order of business and the technology workers would add their own touches to lighten the mood when appropriate!

In conclusion, General Assembly 226 was a success and I am happy to bring back goodnews of the good work accomplished at Salt-Lake City! It was an honor to be given the opportunity to participate and work alongside my fellow siblings in Christ from the Beaver-Butler Presbytery as well as the other commissioners and YAADS I met at Salt-Lake City!

## IN RESPONSE TO ONGOING CONCERNS REGARDING CULTURAL AND SOCIAL ISSUES

The Assembly approved a statement denouncing antisemitism and Islamophobia to be used as a study document distributed to all churches and mid councils, encouraging a time of study and reflection.

The Assembly voted to **reject Christian Zionism in all forms** and to expand its 2004 policy on the understanding of Christian Zionism, issuing a study document.

In response to the ongoing climate crisis, the Assembly voted to direct the Presbyterian Mission Agency's Committee on Mission Responsibility Through Investment (MRTI) to immediately identify and **divest from the top 10 fossil fuel companies** that derive most of their profits from the exploration, development, and production of fossil fuel. They directed MRTI to continue engagement with companies on the "Climate Action 100+" list and report back updates to the 227th Assembly.

In a rare moment of widespread consensus, the Assembly overwhelmingly passed a **call to action on gun violence**. Congregations are urged to take intentional action to protect children from gun violence.

Regarding **prison reform**, the Assembly called Presbyterians to contact elected officials at all levels, advocating for ending the use of prolonged solitary confinement in our penal system and the use of prisoners for unpaid labor.

The Assembly approved the addition of "Transgender Day of Visibility" on March 31 to the Presbyterian Planning Calendar.

# HIGHLIGHTS OF THE 226TH GENERAL ASSEMBLY

PREPARED BY PRESBYTERY OF PHILADELPHIA LEADERSHIP

Nestled in the beautiful Wasatch Mountains, Salt Lake City and the Presbytery of Utah hosted the 226th General Assembly of the Presbyterian Church (U.S.A.) for hundreds of commissioners, advisory delegates, mid-council leaders, and guests from around the country and the world. Here are highlights of decisions made by the Assembly.

#### **ELECTION OF CO-MODERATORS & STATED CLERK**

Commissioners elected Rev. Cecelia (CeCe) D. Armstrong and Rev. Anthony (Tony) L. Larson, both from South Carolina, to serve as Co Moderators of the 226th General Assembly.

On July 1st history was made as Rev. Jihyun Oh was elected to serve as the Stated Clerk of the denomination, making her the first woman and first woman of color elected to this high ranking position. She was installed as Stated Clerk at the Assembly immediately after being

Page 22 of 21 cted and will begin her service as Stated Clerk on August 1st.

# ITEMS REQUIRING APPROVAL OF THE MAJORITY OF PRESBYTERIES

Expanding the church's commitment to diversity and inclusion, the Assembly recommended two changes to the Book of Order, to be voted on separately. **Amending F-1.0403 "Unity in Diversity"** to add "gender identity" and "sexual orientation" to the list of protected classes guaranteed full inclusion and participation in the church. **Amending G-2.0104b** with, "the principles of participation and representation found in F-1.0403" added to the list of topics candidates for ordained office would be asked to consider when determining fitness of call.

Other changes for consideration include addressing paid administrative leave, expanding the definition of "congregation" to incorporate "worshiping communities", adding "adults with vulnerabilities" to protection policies, updates on how to respond to minor or vulnerable-adult abuse, adding tweaks to temporary pastoral relationships timelines, as well as a prohibition on the use of Non-Disclosure Agreements.

#### **UPDATES TO THE WORK OF THE WIDER PC(USA)**

They approved a comprehensive review of the "Preparation for Ministry" process looking at subjects such as the efficacy of ordination exams, who oversees them, as well as the various steps in the ordination process. This task force is expected to bring forth any recommendations to the next Assembly.

The Assembly supported the committee's recommendation to disapprove the recognition of the National Caucus of Korean Presbyterian Churches, citing the absence of women in leadership and concerns about the treatment of female clergy as its main reasons. With 330 churches and 40,000 members, Korean congregations are the second largest contingent of color, following our African American churches.

With the shift to the hybrid modality for this Assembly and at the next Assembly, an **overhaul of the Assembly's Standing Rules** was approved. This includes moving the moderator(s) election to the end of the Assembly rather than the beginning, with the newly elected moderator(s), moderating the Assembly at the conclusion of their two-year term. They also revised the number of commissioners and the composition of the advisory delegates. Also, we celebrated that the 227th GA is to be held in Milwaukee, Wisconsin!

The Assembly called for a group of mid-council leaders to work with the Board of Pension to explore adjustments to be made to medical dues plans for pastors and spouse or families.

A resolution was passed to support the **ongoing inclusion of Latino a** - **é ministry within the church.** This includes ways to reimagine and expand such ministries, including a discernment gathering in 2026 to find new avenues to support Latino-a-é leaders and congregations along with funds to support the implementation of these ideas.

Reflecting upon the recommendations from Special Offerings Task Force, the Assembly approved a recommendation taking the PC(USA) Special Offerings from four down to three. In withdrawing the Pentecost offering, they have shifted its supported ministries into a reconfigured Christmas Joy Offering while also updating the "World Communion Offering" receipts to go back to the denomination in support of congregational ministry grants.

Responding to calls for funds to be diverted from the **Self Development of People (SDOP)** towards programs aiding African American congregations, the Assembly chose instead to refer this action to the "New Unified Ministry Agency" trusting in the new agency to discern and explore how best to meet SDOP's vision as well as the needs of our African American congregations.

Five of our Presbyterian seminaries confirmed new presidents, a harbinger of a new season for theological education in the PC(USA).

## BEAVER-BUTLER PRESBYTERY STRENGTHENING CONGREGATIONAL CONNECTIONS GRANT

#### **PURPOSE**

Trusting in Jesus' proclamation that "where two or three are gathered in my name, I am there among them" (Matthew 18:20), the Strengthening Congregational Connections Grant is available to assist congregations partnering together to use their energy, intelligence, imagination, and love in a **new** shared project of ministry and mission. A grant of up to \$500 per each participating PC(USA) congregation of the Presbytery may be available upon application. Applications for projects involving more than three congregations will be considered on a case-by-case basis.

#### **PROCESS**

- With at least one other congregation in the Presbytery, come up with a creative and compelling idea for a new ministry, mission, or fellowship event.
- Complete the attached application form and submit it to the Presbytery Office.
- Upon receipt, the Collaboration, Fellowship and Youth (CFY) ministry unit will consider the application at its next stated meeting and will respond shortly thereafter.

#### REQUIREMENTS

- The proposed initiative must facilitate <u>at least two congregations of the Presbytery</u> working to build the reign of God among Beaver-Butler Presbytery. Initiatives may be ecumenical and/or interfaith, but there must be at least two congregations of the Presbytery involved in leadership and implementation. Only one participating church needs to submit the application, and a representative from this church will be responsible for handling financial matters.
- The Sessions of all churches involved must approve the event and proposed funding.
- Each individual church may only receive one grant per calendar year. Applications will be accepted through November 30, 2023. CFY will evaluate the grant process at the end of 2023 for future consideration.
- Upon approval, the initiative may be shared so others can also participate.
- The event must happen within twelve months of receiving the funds.
- Following the event, photos/videos and feedback should be shared with CFY.

#### **INFORMATION TO CONSIDER**

- If you have an idea for an event but aren't sure who might make a good partner, share your idea with local churches to see if another congregation may be interested. The Presbytery Office and CFY can also help you make connections.
- The purpose of this grant is to fund **new** ministries, missions, or fellowship events. This does not mean something that's never been done before *anywhere*, but rather something new for this particular collective of congregations.
- If the proposal does not fall within the requirements and intent of this grant, CFY will be in conversation with you regarding possible revisions.
