The church sits at the intersection of Rt. 68 and Big Knob Road, called "Sunflower Corners" and is located between Rochester and Zelienople. The church has a red-brick building with a white steeple, and is placed along a sloping hill.

For those coming from Butler County:

Make your way to Zelienople. Then take Rt. 68 west and south out of Zelienople toward Rochester. The church is 7 miles from Zelienople, at an intersection where Rt. 68 makes a 90-degree turn to the right. However, the church is on the left: <u>Turn left</u> onto Big Knob Road, and then turn left again at the first driveway on your left.

For those coming from Beaver County:

Make your way onto Rt. 68 in Rochester. Rt. 68 turns left (onto Virginia Ave) at a Sheetz. Continue on Rt. 68/Virginia Ave past the Rochester High School, and on for 3 miles until you reach a "stop" sign. At this intersection Rt. 68 makes a 90-degree left turn. However, the church will be plainly visible immediately ahead. <u>Go straight</u> onto Big Knob Road, crossing the intersection and then turn left at the first driveway on your left.

Parking is behind the church.

When you *exit* the parking lot, you will be directed to a 1-way exit onto Rt. 68, near the intersection of Rt. 68 and Big Knob Road.

History of New Sewickley Presbyterian Church in Beaver County, Pennsylvania

In the spring of 1957, Ray Speedy, a resident New Sewickley Township, discussed the need for a Presbyterian church in this area. On June 1, 1958, the national Missions Committee secured Kenneth Gordon, a senior at Pittsburgh-Xenia Seminary to conduct services during the summer months. On June 15, 1958, the first worship service was held in the Big Knob Grange Hall with 58 persons attending, and 41 attending Sunday School. This church was listed as a Mission Church and accepted 48 people into the membership of the Presbytery.

Communion was first observed on July 6, 1958, with 51 communicants. By-laws were accepted on July 18, 1958. James McIntyre, a junior at the Pittsburgh-Xenia Seminary, served as pastor from September 1958 until June 1959. The Presbytery then appointed Rev. Lloyd Crall to serve as supply pastor. Rev. Crall left at the end of July 1959 and Rev. Robert H. Phillips was then appointed as supply pastor. On January 9, 1959, 48 members were officially received and recognized, and seven infants were baptized.

By December 1960, the total membership was 108. In July 1962, the Presbytery purchased 7.744 acres on the corner of Rt. 68 and Big Knob Road for \$13,000. Ground was broken on April 5, 1964, and on June 7, 1964, the cornerstone was laid. The first worship service in the new building was held on December 6, 1964, with 144 attending. A narthex was added in 1979, and a new fellowship hall with basement was added in 1998.

After 16 years, Rev. Phillips ended his service with NSPC in January 1975, and Rev. Dan Schomer was elected to serve as minister and served until September 1979. Rev. Keith Johnston served from May 1980 until August 1987. Rev. Lance Chapman served as interim pastor until 1988. Rev. Ron Kronk was installed on July 10, 1988, and served 18 years, through October 2006. Rev. Thomas Clyde then served as interim pastor. Rev. Dan Callahan was installed on March 1, 2009 and served until October 2014. The Rev. Dennis Burnett, served from 2015 through August of 2020. Rev. Beth Wierman has served since April of 2021.

For 66 years, NSPC has served New Sewickley Township and the surrounding areas. We are home to Cub Scout Pack #444. We traditionally host a Live Nativity and a Holy Week event for the community. From Vacation Bible School and afternoon movies in the fellowship hall to bible study and special worship services, the congregation continues to share the love of Christ. The church is blessed with a true intergenerational network of relationships. With monthly mission activities

connecting members to various community efforts such as serving at Twelve Loaves in New Brighton, collecting food for Christopher's Kitchen at Children's Hospital, and each fall filling back packs for children in local schools, the community of faith is attempting to serve as we have been served. We continue *Planting Seeds of Hope at Sunflower Corners and Growing a Community of Disciples*.

Proposed Amendments to the Constitution of the PC(USA) Approved by the 226th General Assembly (2024)

Deleted text is in strikethrough; added text is in bold *italics*.

Ministry and Vocation

24-A — F-1.0403 UNITY IN DIVERSITY (POL-01 1)

Shall F-1.0403 in the Foundations of Presbyterian Polity be amended as follows? (Deleted text is in strikethrough; added text is in italics.) "F-1.0403 Unity in Diversity ... The unity of believers in Christ is reflected in the rich diversity of the Church's membership. In Christ, by the power of the Spirit, God unites persons through baptism regardless of race, ethnicity, age, sex, *gender identity*, *sexual orientation*, disability, geography, or theological conviction. There is therefore no place in the life of the Church for discrimination against any person. The Presbyterian Church (U.S.A.) shall guarantee full participation and representation in its worship, governance, and emerging life to all persons or groups within its membership. No member shall be denied participation or representation for any reason other than those stated in this Constitution.

24-B – G-1.0104 OTHER FORMS OF CORPORATE WITNESS (WORSHIPING COMMUNITIES, etc.) (POL-03)

In circumstances where the formation of a traditional ecclesiastically and legally organized congregation is not desired or deemed appropriate, and a worshiping community has been formally recognized by a presbytery according to its own definition, presbyteries and congregations may work together with such a group to provide supervision and support. Such recognized groups shall be under the mutually agreed upon oversight of a minister of the Word and Sacrament approved by the presbytery, shall include at least one ruling elder in their chosen leadership, and shall function under the financial, legal, and disciplinary sponsorship of an ecclesial council (either a session or a presbytery). The sponsoring council shall, in consultation with the worshiping community, authorize any celebrations of the sacraments within the group in accordance with the Directory for Worship. Membership records for group participants desiring to be formally enrolled as baptized, active, or affiliate members in the PC(USA) shall be maintained by the sponsoring council. Such groups shall not hold property, and may not undertake any financial, legal, or contractual obligations, apart from their sponsoring council. They shall adhere to the sponsoring council's required policies on sexual misconduct, harassment, child and youth protection, and antiracism. Presbyteries shall determine appropriate means of representation and participation of such groups in and through the sponsoring councils (session and/or presbytery).

24-C — G-2.0104b GIFTS AND QUALIFICATIONS (POL-01 2)

b. Standards for ordained service reflect the church's desire to submit joyfully to the Lordship of Jesus Christ in all aspects of life (F-1.02). The council responsible for ordination and/or

installation (G-2.0402; G-2.0607; G-3.0306) shall examine each candidate's calling, gifts, preparation, and suitability for the responsibilities of ordered ministry. The examination shall include, but not be limited to, a determination of the candidate's ability and commitment to fulfill all requirements as expressed in the constitutional questions for ordination and installation (W-4.0404), the Historic Principles of Church Order (F-3.01), and in the principles of participation and representation found in F-1.0403. Councils shall be guided by Scripture and the confessions in applying standards to individual candidates.

24-D — G-2.0504b TEMPORARY PASTORAL RELATIONSHIPS (POL-05)

Titles and terms of service for temporary relationships shall be determined by the presbytery. A person serving in a temporary pastoral relationship is invited for a specified period not to exceed twelve thirty-six months in length, which is renewable with the approval of the presbytery.

24-E — G-2.0504b TEMPORARY PASTORAL RELATIONSHIPS (POL-08 2)

Temporary pastoral relationships are approved by the presbytery and do not carry a formal call or installation. When a congregation does not have a pastor, or while the pastor is unable to perform her or his duties, the session, with the approval of presbytery, may obtain the services of a minister of the Word and Sacrament, candidate, or ruling elder in a temporary pastoral relationship. No formal call shall be issued and no formal installation shall take place.

Titles and terms of service for temporary relationships shall be determined by the presbytery. A person serving in a temporary pastoral relationship is invited for a specified period not to exceed twelve months in length, which is renewable with the approval of the presbytery. A minister of the Word and Sacrament employed in a temporary pastoral relationship is ordinarily not eligible to serve as the next installed pastor, co- pastor, or associate pastor.

When the temporary pastoral relationship ends, no non-disclosure agreement shall be allowable.

A non-disclosure agreement, also known as a confidentiality agreement, is an agreement that outlines confidential material, knowledge, or information that is to remain confidential. Such an agreement binds the party or parties who have signed it and prevents them from discussing any information included in the contract with anyone not authorized by the agreement.

24-F — G-2.0610 ACCOMODATIONS TO PARTICULAR CIRCUMSTANCES (ORD-05)

When a presbytery concludes there are good and sufficient reasons for accommodations to the particular circumstances of an individual seeking ordination, it may, by a three-fourths vote, waive any of the requirements for ordination in G-2.06, except for those of G-2.0607d. If a presbytery judges that there are good and sufficient reasons why a candidate should not be required to satisfy the requirements of G-2.0607d, it shall approve by three-fourths vote some alternate means by which to ascertain the readiness of the candidate for ministry in the areas covered by the standard ordination examinations. A full account of the reasons for a *The existence of* any waiver or alternate means to ascertain readiness, with confidential details omitted, shall be included in the minutes of the presbytery and communicated to the presbytery to which an inquirer or candidate may be transferred.

22-G — G-2.0901 CONGREGATIONAL MEETING (POL-08 1)

An installed pastoral relationship may be dissolved only by the presbytery. Whether the minister of the Word and Sacrament, the congregation, or the presbytery initiates proceedings for dissolution of the relationship, there shall always be a meeting of the congregation to consider the matter and to consent, or decline to consent, to dissolution. *No non-disclosure agreement shall be allowable.*

A non-disclosure agreement, also known as a confidentiality agreement, is an agreement that outlines confidential material, knowledge, or information that is to remain confidential. Such an agreement binds the party or parties who have signed it and prevents them from discussing any information included in the contract with anyone not authorized by the agreement.

24-M Episcopal-Presbyterian Agreement on Local Sharing of Ministries

The agreement is published in the document: Proposed Amendments to the Constitution and Episcopal-Presbyterian Agreement on Local Sharing of Ministries booklet (provided).

24-H — G-3.0106 ADMINISTRATION OF MISSION (POL-11)

All councils shall adopt and implement the following policies: a sexual misconduct policy, a harassment policy, a child, and youth, and *adults with vulnerabilities* protection policy, and an antiracism policy. Each council's policy shall include requirements for boundary training which includes the topic of sexual misconduct, and child sexual abuse prevention training for its members at least every thirty-six months.

24-I — G-3.0302d RELATIONSHIPS WITH SYNOD AND GENERAL ASSEMBLY (GAP-05)

d. proposing to synod such measures as may be of common concern to the mission of the church, and/or proposing to General Assembly overtures that have received a concurrence from at least one other presbytery, and/or concurring with proposed overtures, and

24-J — G-3.0501 COMPOSITION AND RESPONSIBILITY (GAP-04)

The General Assembly is the council of the whole church, and it is representative of the unity of the synods, presbyteries, sessions, and congregations of the Presbyterian Church (U.S.A.). It shall consist of equal numbers of ruling elders and ministers of the Word and Sacrament elected by the presbyteries and reflective of the diversity within their bounds (F1.0403 and G-3.0103), to serve as commissioners according to the following proportions:

8,000 6,000 members or less: 1 ruling elder and 1 minister of the Word and Sacrament 8,001–16,000 6,001-12,000: 2 ruling elders and 2 ministers of the Word and Sacrament 16,001–24,000 12,001-19,000: 3 ruling elders and 3 ministers of the Word and Sacrament 24,001–32,000 19,001 or more: 4 ruling elders and 4 ministers of the Word and Sacrament 32,001–40,000: 5 ruling elders and 5 ministers of the Word and Sacrament 40,001–48,000: 6 ruling elders and 6 ministers of the Word and Sacrament 48,001 or more: 7 ruling elders and 7 ministers of the Word and Sacrament

Permanent Judicial Commission

24-K — D-7.0501 REFERRAL TO INVESTIGATING COMMITTEE (POL-02)

When a clerk of session or the stated clerk of a presbytery receives an allegation, without undertaking further inquiry, that clerk shall then report to the council only that an offense has been alleged without naming the *person* accused or the nature of the alleged offense and *shall* refer the statement of allegation promptly to an investigating committee, which shall conduct an inquiry as defined below. *Pursuant to G-4.0302, the clerk shall report to civil legal authorities any knowledge of harm, or risk of harm, related to the physical abuse, neglect, and/or sexual molestation or abuse of a minor or adult lacking mental capacity. The clerk of session or stated clerk shall also inform the accuser of the disciplinary process and their rights and responsibilities in the process.*

24-L — D-7.0902b ADMINISTRATIVE LEAVE (POL-04)

Regardless of the employment status of the minister of the Word and Sacrament, the members designated in accordance with D-3.0102, shall determine as quickly as possible, after receiving the written allegations and providing the accused an opportunity to be heard, whether the risk to a congregation and/or to other potential victims of abuse requires *paid* administrative leave or other restrictions upon the minister's service when considered in light of the nature and probable truth of the allegations. Such paid administrative leave or restrictions will continue until either the matter is resolved in one of the ways prescribed in the disciplinary process or until the leave or restrictions are altered or removed by members of the commission. *The cost shall be borne by the employing entity whenever possible or be shared by the presbytery as necessary*.

A GATHERING OF THE CHURCHES OF BEAVER-BUTLER PRESBYTERY September 24, 2024, 4:00 PM

The Beaver-Butler Presbytery held a stated meeting at 4:00 PM on Tuesday, September 24, 2024. The meeting was held at the New Galilee Community Center, and jointly hosted by the First United, Darlington and The Galilean Presbyterian Churches, where Rev. Dr. Judy Angleberger serves as Pulpit Supply. The meeting was moderated by Presbytery Vice-Moderator Elder Dennis Krebs.

Before the meeting, training was held for new Elder Commissioners (or anyone else wanting a refresher). Future meetings will have similar training sessions.

Vice-Moderator Krebs called the meeting to order at 4:10 PM and affirmed the presence of a quorum with Stated Clerk Rev. Randall Clow.

WELCOME FROM THE HOST CHURCHES:

Elder Paul Morrison

Elder Morrison gave information to the Presbyters regarding exits, restrooms, and fellowship.

LOCAL CHURCH MISSION:

Bonnie Goehring/Homer Ray, Eileen Yoder

Bonnie spoke about their work at City Rescue Mission of New Castle. Their partnership has included visiting ministers, scholarships for local students, and a food bank. Community support also includes insurance deductible payment, homeless support, and the Salvation Army.

WELCOME OF NEW ELDERS AND PASTORS:

There were no First-time Commissioner Elders or Pastors.

PRAYERFUL CALL TO WORSHIP:

Vice-Moderator Krebs opened the meeting with prayer.

GATHERING HYMN: "Here in This Place"

THE WORD READ: 1 Samuel 16:1-13

THE WORD SPOKEN: "Shallow" Rev. Dr. Judy Angleberger Judy read the account of the call of Samuel and his mission to Jesse to anoint the next King. Various sons of Jesse coming before Samuel, until David (whom Jesse had ignored) was called in to be anointed. The LORD said to Samuel, "Arise and anoint him, for this is the one."

She told of watching a movie, "Shallow Hal" – stars Jack Black and Jason Alexander only wanted to be associated with "beautiful people." Jack gets trapped in an elevator with Tony Robbins, a well-known self-help guru. Tony hypnotizes Jack, and Jack only sees the inner beauty of the people he meets.

He only sees inward essence, and Jason Alexander can't understand why Jack is to attracted to people they would have avoided before. Jason cannot see what he sees in this particular person (Gwyneth Paltrow). In one scene, "beautiful" Gwyneth sits on a chair and it collapses!

As the hypnosis wears off, Jack resumes seeing people from the outside. As it turned out, Ms. Paltrow was a very overweight person! Jack is confused – to which one am I attracted? The inner Gwyneth, or the outer?

Judy chose not to reveal the ending (!), but reminded us, through the film and the account of the anointing of David, how we all do the same! We ARE GUILTY of looking only at how folks appear on the outside! (Judy spoke about a personal experience when she actually saw herself!) We all look at people on the outside, but through the calling of David, we are encouraged to look at each other's hearts!

MVC Report to Beaver-Butler Presbytery as a Commission to Examine a Pastor for an Installed Position.

Using the procedures in "On examining ordained Ministers of the Word and Sacrament (Teaching Elders/Pastors) for membership in Beaver-Butler Presbytery." (Approved November 2023) The Ministry and Vocation Committee examined and approved The Rev. Kalyn Stevwing to become the installed pastor at Ohio United Presbyterian Church on behalf of Beaver-Butler Presbytery.

Actions of MVC:

Having received a report from the "Meet and Greet" team on May 6th, the MVC provided an examination by the full MVC on behalf of the Presbytery: MVC received the prospective pastor's PIF/PDP, Statement of Faith, and Terms of Call in agreement with Session and PNC before its meeting.

MVC's discussion with the prospective pastor included, but was not limited to, the following questions:

What events or persons have significantly affected your ministry?

What theological truths have emerged as critical to your practice of ministry?

What experiences have challenged or affirmed your ministry?

How do the sacraments influence your practice of ministry?

What part does Scripture play in your ministry's practice, presentation, and application?

How has the fellowship of the presbytery body helped in your ministry?

With what or how can the Beaver-Butler Presbytery help you in the practice of your ministry?

Having sustained the examination, the MVC passed the following motion:

Motion: The Ministry and Vocation Committee, acting as a commission of the Presbytery, approved a motion, if the way be clear, the call of the Rev. Kalyn Stevwing to the Ohio United Presbyterian Church to receive Rev. Stevwing as a member of Beaver-Butler Presbytery, approve the terms of call as presented, and request the moderator of the Presbytery to appoint an Administrative Commission to install Rev. Stevwing at a time to be determined. The effective date is August 5, 2024. - PASSED

Actions of Ohio United Presbyterian Church:

The Ohio United Presbyterian Church approved Rev. Stevwing as their Installed pastor on June 2, 2024.

Terms of Call - Rev. Kalyn Stevwing

Salary \$50,000 with use of Manse, SECA \$3,825, BOP on Pastor's Participation, two weeks study leave with \$1,200 allowance, one month vacation including 4-5 Sundays, 12 weeks family medical leave, mileage reimbursement at IRS Rate, stipend for moving/housing/relocation expenses.

Statement of Faith - Rev. Kalyn Stevwing

There is one God, who created each element of the world and declared all of creation to be good. As a parent, God comforts and welcomes all who have been lost, not excluding any of God's creations. The anger of God and the love of God can and do exist together, as witnessed in the book of Jeremiah. While God punishes the people through exile, God also reminds and promises that there is a plan. The Holy Spirit gives us strength to live joyful, holy lives, pray unceasingly, witness to others, and to hear and lift the voices of the powerless in the world. We are empowered to live our daily lives in service to Christ and invited to be ministers of the church through the Holy Spirit.

Upon birth we inherit a sinful nature. This nature affects who we are and will lead us to oppose God's will, to sin, in our lives. We deserve God's judgment and punishment yet God redeems all, forgiving all who repent. Nothing can separate us from the love of God in Christ Jesus our Lord and Savior.

The Church is a community of believers called into the world by Christ to make disciples. The Church gathers to praise God, hear the Word of God, administer the sacraments properly, pray for and present the world to God in worship, enjoy fellowship, and to encourage and teach believers to go into the world.

There are two sacraments instituted by Christ to the church: Baptism and the Lord's Supper. These sacraments are visible signs of an inward grace, open and available to all. In them we claim God's promises in Christ and affirm God's presence in our lives. Baptism marks an individual's entry into the family of faith. Through the waters of baptism, we receive by faith the promises of God through the power of the Holy Spirit. Through the Lord's Supper, we are sustained, and we join with others in receiving the promise of the new covenant, remembering the death and resurrection of Jesus, until he comes again.
