226th General Assembly (2024) Amendments to the Book of Order:

Twelve Amendments to and one Ecumenical Agreement for the *Book of Order* were considered and voted upon by the Presbyters. The various Amendments were assigned to The Coordinating Team, Ministry & Vocation, and the Permanent Judicial Commission for recommendation (*Approve or Disapprove*).

The recommendations for *seven Amendments and the Ecumenical Agreement* were approved as part of a Consent Agenda. The *five remaining Amendments* were removed from the Consent Agenda for individual discussion and voting by the body. The recommendations for all five Amendments were PASSED (i.e., the Presbyters AGREED with the various Committee recommendations; details may be obtained from Rev. Randall Clow, Stated Clerk.)

All one hundred sixty-six Presbyteries will vote on the Amendments and the Ecumenical Agreement. Presbyteries must submit their votes to the Office of the General Assembly by July 4, 2025. Results will be announced at a future Presbytery meeting. Approved Amendments will be added to the *Book of Order*.
